## Election day is Feb. 12, 2019

Bainbridge Island School District is placing a **\$15 million capital levy on the February 12, 2019 ballot.**

If approved, the \$15 million will provide funding to:

- Complete the replacement of the 100 Building at Bainbridge High School and transform the current BHS commons into an auditorium. (This project is mostly funded from the 2016 bond.)
- Provide funding through 2025 for repairs and renovations (such as school security upgrades).

Since the time of the 2016 bond's approval, the greater Seattle region has experienced a construction boom which has resulted in increased prices for labor and materials. This escalation, coupled with state funding that didn't fully materialize and new building codes, have resulted in a funding shortfall for BISD projects identified in the 2016 Bond.

"Our public schools are the heart of our community," said Superintendent Peter Bang-Knudsen. "By investing in our school infrastructure, we will continue to provide an optimal education for students now and in the future."

If approved, the levy will cost homeowners \$0.30 per thousand assessed value, about \$198 per year for six years for the average Bainbridge Island home (which is assessed for \$660,520).

### FAQs:

**Q:** Why doesn't the district put the projects on hold and wait for the construction industry to slow down?  
**A:** Money would be needed to patch and repair the 100 building such as re-roofing and updating its electrical, fire and structural systems; postponing does not provide the space necessary to support 21st century learning.

**Q:** How have the plans evolved for BHS remodel since 2016?

**A:** The plans now involve moving the commons to the 100 Building, which will make the commons the heart of the campus. Doing so allows for:

- Open access/full utilization of the space during the day for classroom support; allows school administrators to keep watchful eyes on the space.
- Transforming the current commons into an auditorium with seating for 350-400. The space offers an ideal environment for transformation — the original design intent provides visual access and supports all elements of performance activities.
