

## **BAINBRIDGE HIGH SCHOOL STUDENT PARKING PERMIT AGREEMENT 2018-2019**

All Parking Permit Applications must be completed **online** prior to receiving a pass.

Parking permits are \$250.00 per spot for the entire school year.

There are no payment plans or reduced fees for Parking.

All applications must be received by Friday, September 7, 2018 at 3:00pm in order to be considered for a parking pass. Seniors, to be considered for the FIRST round of parking permits, please complete your application by Thursday, August 23. Passes will be issued based on availability by seniority (Seniors then Juniors). If there are more applications than spots available, passes will be drawn by a lottery. Payments can be made to Sarah Spray in the BHS Accounting office after you have been notified through your school (@frogrock.org) email address. The list of students receiving parking permits for the first round will be posted by the Accounting office on August 30. The SECOND round notifications will begin Sept. 7, with an updated list posted by September 11th at 8AM. Parking permits will not be issued until payment has been made (and all fines paid), or the parking pass will be issued to another student. Parking lot restrictions will be enforced beginning September 12th.

Due to the limited number of spaces we ask that you limit your parking permit to one permit per household. Parking permits may not be sold or transferred to a second party. A student who is assigned a parking spot may let another student temporarily use his/her permit. The registered student is responsible for their permit and the actions of any student who borrows your permit at all times. (Keep this in mind before letting a student use your permit).

Students must display their parking permit on their rear view mirror inside their vehicle at all times. Parking areas are color coded and the registered vehicle must be parked in your assigned lot . Failure to do so may result in a parking ticket or having the vehicle towed at the student's/owner's expense.

Students park at their own risk. BHS is not responsible for theft or damage to student vehicles at any time. BHS is not responsible for any resulting impound costs of registered/non-registered vehicles.

The speed limit on campus is 10 mph and pedestrians have the right of way at all times on school grounds. All cars should be locked at all times.

IF YOU USE THE BUS LANE ON THE WEST SIDE OF THE COMMONS/LUNCHROOM... YOUR PERMIT WILL BE REVOKED AND YOU WILL NOT GET A REFUND... THIS LANE IF FOR BUSES ONLY! Speeding, reckless driving, spinning of tires, etc...on school property or on adjacent streets to the high school will result in loss of parking privileges and a fine. Use of the bus lane coming in or out of the east entrance of the school will result in loss of parking privileges and a fine.

For student's protection, the parking lot is a restricted area during school hours. Only those students who are authorized to leave campus may be in the vehicles at the time they are coming and going.

Students are **NOT** allowed to park before, during or immediately after school in designated visitor, staff and swimming pool parking spaces. Students with parking permits must park between the two white lines of assigned space in student parking lots.

If a student violates any of the school's parking rules and regulations listed above, the following action will be taken:

1st Offense: \$25.00    2nd Offense: \$35.00

3rd Offense: \$45.00    4th Offense: \$45.00 fine and loss of parking privilege

If you receive a citation, it is your responsibility to work with the school security officer and/or Student Court. Permits may be withdrawn or suspended for failing to comply with the conditions cited at the discretion of the administration. Students who park diagonally, speed, or loiter can have their parking permit revoked. Any attempt to make copies of parking permits will result in the loss of parking privileges to all those involved. **A car may be towed away at the student's expense.** BHS is not responsible for theft or damage to vehicles. Students park at their own risk.

I have read and understand all the above school parking regulations. I have adequate insurance as is required by law. I agree to abide by the parking lot policy and understand the school may take appropriate disciplinary actions should the applicant fail to abide in the spirit of the regulations.
